

CYBRA Corporation Software License Agreement

CYBRA grants, and Licensee accepts, a nonexclusive and nontransferable license to use each of the software product(s) specified in the Program List attached hereto, in object code form, during the term hereof.

LICENSE

Each licensed Product may only be used on a single Server and single partition and/or MAC Address (where applicable) as designated in the Program List. Licensee may not re-license the Program or use the Program for third-party training, commercial time-sharing, Application Service Provider (ASP) hosting purposes, Software as a Service (SaaS), rental or service bureau use. In the case where a Licensee intends and desires to use the Product on two or more partitions (where applicable) on the same Server (LPAR Option - where applicable), an additional Product license must be purchased. Licensee agrees not to sell, give, assign, sublicense or otherwise transfer or disclose the Product(s) or any part thereof to any person, firm, agency or corporation; Licensee warrants and agrees to exercise all precautions to preserve the proprietary aspects of the Product(s), their systems and all related materials; Licensee may copy the Program for archival or backup purposes; no other copies shall be made without CYBRA's prior written consent. All titles, trademarks, and copyright and restricted rights notices shall be reproduced in such copies. All archival and backup copies of the Programs are subject to the terms of this Agreement. Licensee agrees not to cause or permit the modification, reverse engineering, disassembly or de-compilation of the Product(s). CYBRA shall retain all title, copyright and other proprietary rights in the Product(s), and Licensee shall not mask, modify or suppress any notices of such rights. Licensee does not acquire any rights, express or implied, in the Product(s), other than those specified in this Agreement.

TERM

The license granted by this Agreement will remain in effect perpetually, unless terminated. Licensee may terminate the license at any time by returning to CYBRA the Product(s) and all related materials. The license will also terminate if Licensee fails to comply with any term or condition of this Agreement. The Licensee agrees that upon such termination it shall return to CYBRA each of the Product(s), all copies and all related materials. Termination shall not relieve Licensee of its obligations hereunder, nor limit either party from pursuing remedies legally available to it.

LIMITED WARRANTY

CYBRA will provide the Licensee with an accurate reproduction of the Product(s) licensed by this Agreement, and an accurate copy of the respective User's Guide associated with such Product(s). Any defects not caused by Licensee's negligence that become evident within thirty (30) days from the date of delivery will be corrected by CYBRA with no cost to the Licensee. The Licensee's sole & exclusive remedy in the event of a defect is limited to correction of the defect by adjustment, replacement, or repair, in each case at CYBRA's election in its sole and complete discretion. In no event will CYBRA be liable for indirect, incidental, or consequential damages, including lost profits. CYBRA MAKES NO OTHER WARRANTIES, WHETHER WRITTEN, ORAL OR IMPLIED, INCLUDING, WITHOUT LIMITATION, IMPLIED WARRANTIES OF MERCHANTABILITY OR WARRANTY OF FITNESS FOR PARTICULAR PURPOSE. CYBRA does not warrant that the Product(s) will meet Licensee's requirements that the Product(s) will

operate in the combinations that Licensee may select for use, that the operation of the Product(s) will be uninterrupted or error-free, or that all Product errors will be corrected. Any computer-based training products are distributed "as is."

PRODUCT RIGHTS

CYBRA warrants that it has all requisite rights to the Product(s) listed in the Program List below and agrees to defend, or settle, at its option, any action at law against Licensee arising from a claim that Licensee's use of the Product(s) under this Agreement infringes any patent or property right provided that: Licensee notifies CYBRA in writing within 30 days of the claim; CYBRA has sole control of the defense and all related settlement negotiations; and Licensee provides CYBRA with the assistance, information and authority necessary to perform CYBRA's obligations under this Section. CYBRA shall have no liability for any claim of infringement based on use of a superseded or altered release of Product(s) if the infringement would have been avoided by the use of a current unaltered release of the Product(s) which CYBRA provides to Licensee. In the event the Product(s) are held or are believed by CYBRA to infringe, CYBRA shall have the option, at its expense, to modify the Product(s) to be non-infringing; obtain for Licensee a license to continue using the Product(s); or terminate the license for the infringing Product(s) and refund the license fees paid for those Product(s), prorated over a five year term from the Commencement Date. THE FOREGOING STATES THE ENTIRE LIABILITY OF CYBRA AND THE EXCLUSIVE REMEDY OF THE LICENSEE WITH RESPECT TO ANY ALLEGED PATENT OR PROPERTY RIGHT INFRINGEMENT. Licensee's sole and exclusive remedy for CYBRA's failure to perform hereunder shall be recovery of the fees paid by it to CYBRA in respect of the relevant Product(s). The provisions of this Agreement allocate the risks between CYBRA and Licensee. CYBRA's pricing reflects this allocation of risk and the limitation of liability specified herein.

COMPENSATION

The Licensee agrees to pay CYBRA the license fee(s) for the Product(s) in accordance with the fee schedule specified in the Program List attached. All fees are payable in full upon execution. All fees are non-refundable and fully-earned at receipt.

TAXES

Any sales, use, property, value-added or other governmental taxes or duties due by reason of the Product(s) furnished under this Agreement are the Licensee's responsibility, and shall be paid by it promptly, exclusive of taxes based upon CYBRA's net income.

VERIFICATION

At CYBRA's written request, not more frequently than annually, Licensee shall furnish CYBRA with a signed certificate verifying that the Product(s) are being used pursuant to the provisions of this Agreement, including any Server limitations. CYBRA may, at its expense, audit Licensee's use of the Product(s). Any such audit
